- 11. Describe the consumer experience when presenting to the dispensary for medical versus recreational purposes.
- 12. Examine how the role of the healthcare professional has changed since legislation allowed for adult-use.
- 13. Discuss ways to bridge gaps in care between non-medical consumers and medical patients.
- 14. Evaluate the role of healthcare professionals in states that are considering allowing for adult-use.
- 15. Summarize resources available to healthcare professionals in states that allow medical and adult-use cannabis.
- 16. Define comprehensive medication management (CMM).
- 17. Compare and contrast comprehensive medication management (CMM) to medication therapy management (MTM).
- 18. Examine the purpose and contents of a collaborative practice agreement.
- 19. Analyze the process for collaborating with a physician to provide CMM services.
- 20. Identify required documentation to ensure successful reimbursement with third party payers.
- 21. Summarize the legal considerations for billing insurance for CMM services.
